TOPIC

The 1985 Hague Convention on the Law Applicable to Trusts and on their Recognition has been in force in Switzerland for almost ten years now. This international instrument has generated just a few, although controversial, Swiss court decisions so far. As a result, it may be interesting to have a look at some of the case law and judicial practices developed in other signatory countries – including some trust jurisdictions such as the United Kingdom or Canada, as well as non-trust jurisdictions, such as Italy or Monaco – that might be of interest for the Swiss practice. This is what Gian Paolo Romano's proposed talk attempts to do.
