# "FATCA and the Trust Industry - Current Practical Issues"

FATCA has wide reaching consequences for banks and trust practitioners. This event will focus on practical issues currently encountered by Swiss banks and their clients in the implementation of FATCA / IGAs in relation to accounts held in trust: classification of trustees, trusts and underlying companies, documentation to be furnished to banks illustrated by concrete templates of IRS and banking forms, reporting requirements. We will further discuss how these duties compare with those set forth in the draft bills concerning the automatic exchange of information in tax matters recently published by the Swiss Federal Council.

This topic will be addressed by **Dr Erol Baruh**, who will speak English, but will be happy to answer questions in French.

Dr Baruh holds a Ph.D. in law. He is a senior lawyer with the major Swiss law firm Schellenberg Wittmer, where he advises several financial institutions in relation to FATCA.

The presentation will begin at 12:00, followed by lunch. The meeting will close at 14:00.
